Dear Ms. Ferrell:

Enclosed please find a copy Kanawha County Commission's Order amending the Kanawha County E911 Ordinance. The Commission voted to amend its ordinance during a public hearing held on September 24th at 5:30pm. The amendment and public hearing was held in accordance with the requirements of W.Va. Code 24-6-6.

Kanawha County Commission and Metro 911 is requesting an effective date of October 1st 2015; however, it is our understanding that under PSC rules service providers and billing agents will have up to 120 days to implement new fee scheduled. C.S.R 150-32-3. Billing and Collection of E911 Fees.

By letter dated August 27th 2015, notice of the proposed revisions to the E911 ordinance was provided to all affected line/VOIP service providers and billings agents. All service providers and billing agents impacted by this proposed increase will received a signed copy of the final order as well.

At a Regular Session of the County Commission of Kanawha County, West Virginia, held at the Courthouse thereof, on the 24th day of September, 2015, the following Order was made and entered:

SUBJECT: Amendment to Countywide Enhanced Emergency Telephone System (E-911) Ordinance

The following Motion was offered by Dave Hardy, Commissioner.

The County Commission of Kanawha County, West Virginia, does hereby amend the Countywide Enhanced Emergency Telephone System (E-911) Ordinance as follows:

- **Page 8, Section 12 - Imposition of Fee (a):** Pursuant to § 7-1-3cc of the West Virginia Code, the Kanawha County Commission shall impose a fee of \$8.96 per month per local business exchange service line and \$5.60 per month per local residential service line, include voice-over-internet protocol and digital service, to finance the projected costs of establishing, equipping, furnishing and maintaining the enhanced emergency telephone system. Said fee shall be effective immediately upon implementation of fee by all competitive local exchange carriers and other carriers whose subscribers are responsible of paying a fee pursuant to West Virginia Code § 7-1-3cc. Tel-e-assistance services shall be exempt from the fee imposed by this section.
- **Page 8, Section 12 - Imposition of Fee (b):** To equalize the rate charged to PBX and Centrex systems, PBX and Centrex lines will be charged at the rate of \$8.96 per line per month. The fee for Centrex and PBX and similar systems is \$8.96 per line per month for the first eight lines and at the rate of \$1.60 per month for all additional lines.


