RULES AND REGULATIONS

I. <u>Rules and Regulations for the Government of Water Utilities</u>, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

APPLICABILITY

Applicable within the entire territory served.

AVAILABILITY OF SERVICE

Available for residential, commercial, industrial and public authority service.

(I) RATES (For all customers with metered water supply)

First	2,000 gallons used per month	\$11.17 per 1,000 gallons
Next	18,000 gallons used per month	\$10.30 per 1,000 gallons
All over	20,000 gallons used per month	\$ 8.35 per 1,000 gallons

(I) MINIMUM CHARGE

No bill will be rendered for less than the following amounts, according to the size of meter installed:

5/8 -inch meter	\$ 22.34 per month
3/4 -inch meter	\$ 33.51 per month
1 -inch meter	\$ 55.85 per month
1 - 1/4 -inch meter	\$ 81.54 per month
1 - 1/2 -inch meter	\$ 111.70 per month
2 -inch meter	\$ 178.72 per month
3 -inch meter	\$ 357.44 per month
4 -inch meter	\$ 558.50 per month
6 -inch meter	\$1,117.00 per month
Board of Education of Tucker County	\$1,261.66 per month

DELAYED PAYMENT PENALTY

The above tariff is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is only to be collected once for each bill where it is appropriate.

RECONNECTION

Fee - \$20.00 To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills, or fraudulent use of water.

(I) TAP FEE FOR NEW SERVICE

On application for new service, the fee shall be as follows:

³ / ₄ inch or less service	\$ 700.00
³ / ₄ inch or less with pressure regulator	\$ 900.00
1 inch or greater service	\$1,000.00

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the City, or a maximum of \$25.00, will be imposed upon any customer whose check for payment of charges is returned to the bank due to insufficient funds.

(I) LEAK ADJUSTMENT

\$1.40 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible leakage on the customer's side of the meter. This rate shall be applied to all such consumption above the customer's historical average usage.

SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific customer class, or fifty dollars (\$50.00), whichever is greater. This fee may be changed by applicable statutory provisions.
