RULES AND REGULATIONS

- I. Rules and Regulations for the Government of Water Utilities, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

APPLICABILITY

Applicable within the entire territory served.

AVAILABILITY

Available for general domestic, commercial, industrial and sale for resale water service.

RATES (Customers with metered water supply)

First	3,000 gallons used per month	\$9.74 per 1,000 gallons
Next	3,000 gallons used per month	\$4.49 per 1,000 gallons
Next	14,000 gallons used per month	\$4.27 per 1,000 gallons
All over	20,000 gallons used per month	\$2.47 per 1,000 gallons

MINIMUM CHARGE

No bill will be rendered for less than the following amounts per month according to the meter size installed:

5/8 inch meter	\$ 29.22 per month
3/4 inch meter	\$ 43.83 per month
1 inch meter	\$ 73.05 per month
1¼ inch meter	\$ 106.65 per month
1 ½ inch meter	\$ 146.10 per month
2 inch meter	\$ 233.76 per month
3 inch meter	\$ 467.52 per month
4 inch meter	\$ 730.50 per month
6 inch meter	\$1,461.00 per month

SALES FOR RESALE RATE

All water for resale to Marshall County Public Service District No. 4 will be billed in accordance with the approved rate of \$1.89 per 1,000 gallons used per month.

TAP FEE

The following charge is to be made whenever the utility installs a new tap to serve an applicant:

A tap fee of \$300.00 will be charged to all customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the system.

RECONNECTION - \$20.00

To be charged whenever the supply of water is turned off for violation of rules, non-payment of bills or fraudulent use of water

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

PRIVATE FIRE PROTECTION

1. For sprinkler systems using 4 to 6 inch lines:
 - A. The customer pays for all the installation and material costs.
 - B. \$27.33 per year for 150 heads, any additional heads, \$0.16 cents per year
2. For Hydrants:
 - A. \$27.33 per year per hydrant on 6 and 8 inch lines.
 - B. The customer pays for all material and installation costs.

LEAK ADJUSTMENT

\$0.56 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible leakage on customer's side of the meter. This rate shall be applied to all such consumption above the customer's historical average usage.

SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific customer class or fifty dollars (\$50.00), whichever is greater. This fee may be changed by applicable statutory provisions.
