

RULES AND REGULATIONS

- I. Rules and Regulations for the Government of Water Utilities, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

APPLICABILITY

Applicable within the entire territory served

(C) AVAILABILITY

Available for residential, commercial, industrial and sale for resale water service.

(I) RATES (customers with metered water supply)

First	2,000 gallons used per month	\$5.37 per 1,000 gallons
Next	3,000 gallons used per month	\$4.10 per 1,000 gallons
Next	35,000 gallons used per month	\$3.22 per 1,000 gallons
Next	40,000 gallons used per month	\$2.42 per 1,000 gallons
All over	80,000 gallons used per month	\$1.64 per 1,000 gallons

(I) MINIMUM CHARGE

No bill will be rendered for less than the following amounts, according to the size of the meter installed:

5/8 inch meter	\$ 10.74 per month
3/4 inch meter	\$ 16.11 per month
1 inch meter	\$ 26.85 per month
1½ inch meter	\$ 53.70 per month
2 inch meter	\$ 85.92 per month
3 inch meter	\$171.84 per month
4 inch meter	\$268.50 per month
6 inch meter	\$537.00 per month
8 inch meter	\$859.20 per month

(I) RESALE RATE

All water for resale to Marshall County Public Service District No. 1 will be billed in accordance with the approved rate of \$0.88 per 1,000 gallons used per month.

(C) RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the utility, not to exceed twenty-five (\$25.00), will be imposed upon any customer whose check for payment of charges is returned by the bank for any reason.

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

RECONNECTION - \$50.00

To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills, or fraudulent use of water.

(C) TAP FEE

The following charges are to be made whenever the utility installs a new tap to serve an applicant:

A tap fee of \$150.00 will be charged to customers applying for service before construction is completed adjacent to the customer's premises in connection with a certificate proceeding before the Public Service Commission of West Virginia. This pre-construction tap fee will be invalid after the completion of construction adjacent to an applicant's premises that is associated with a certificate proceeding.

A tap fee of \$300.00 will be charged to all customers who apply for service outside of a certificate proceeding before the Public Service Commission of West Virginia for each new tap to the system.

(C) LEAK ADJUSTMENT

\$0.30 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible leakage on the customer's side of the meter. This rate shall be applied to all such consumption above customer's historical average.

SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific customer class, or fifty dollars (\$50), whichever is greater. This fee may be changed by applicable statutory provisions.

(C) PUBLIC FIRE PROTECTION SERVICE

The McMechen Public School shall pay a public fire service charge of \$72.00 per annum, payable in twelve (12) equal monthly payments. This charge covers all water system facilities existing at McMechen Public School which are used in whole or in part for public fire service.

The City of McMechen shall pay a public service charge of \$1,404.00 per annum, payable in twelve (12) equal monthly payments. This charge covers all water system facilities existing in the City of McMechen which are used in whole or in part for public fire service.
