RULES AND REGULATIONS

- I. Rules and Regulations for the Government of Water Utilities, adopted by the Municipal Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

APPLICABILITY

Applicable in entire territory served.

AVAILABILITY

Available for general domestic, commercial, industrial and sale for resale water service

RATES - (Customers with metered water supply)

RESIDENTIAL CUSTOMERS

Service Charge	\$6.00 per month
Usage Charge	\$4.50 per 1,000 gallons water usage

COMMERCIAL CUSTOMERS

Service Charge	\$6.00 per month
Usage Charge	\$2.00 per 1,000 gallons water usage

INDUSTRIAL CUSTOMERS

Service Charge	\$6.00 per month
Usage Charge	\$1.29 per 1,000 gallons water usage

(D) SALES FOR RESALE SERVICE

All water for resale to the Hardy County Public Service District or the Hardy County RDA will be billed in accordance with the approved rate of \$1.08 per 1,000 gallons used per month.

TAPPING FEES

A \$500.00 charge shall be made for residential tapping fees.

Commercial fees are based on the size of the meter with a schedule of fees available in the Town Office for the general public.

RECONNECTION

\$25.00 - fee to reconnect water service which has been discontinued for non-payment of bill as per Public Service Commission regulations.

(D) Indicates decrease

DELAYED PAYMENT PENALTY

On all accounts not paid in full within twenty days of the date of billing, ten percent (10%) will be added to the net amount shown.

LEAK ADJUSTMENT RATE

An amount not to exceed \$1.40 per 1,000 gallons is to be used when a bill reflects unusual consumption which can be attributed to eligible leakage on the customer's side of the meter. This rate shall be applied to all such consumption above the customer's historical average usage.

MUNICIPAL EXCISE TAX SURCHARGE

The municipality listed below, having imposed a public utility tax computed on the basis of two percent of revenues from water sales by the Town of Moorefield's water utility within the corporate limits of such municipalities, shall be billed as a "surcharge" to the customers receiving service within said corporate limits.

The water utility is required to collect the utility tax pursuant to West Virginia Code §8-13-5a.

Customers receiving water service within the corporate limits of the specified municipality shall pay a surcharge based on the following surcharge rates:

Municipality of Moorefield - Utility Excise surcharge rate – Two percent (2%) of the gross amount billed.

RETURNED CHECK CHARGE

A service charge of \$25.00 will be charged as per state law on all returned checks.

PRIVATE FIRE PROTECTION FEE

\$200.00 per year.
