RULES AND REGULATIONS

I. Rules and Regulations for the Government of Water Utilities, adopted by the Public Service Commission of West Virginia, and now in effect, and all amendments thereto and modifications thereof hereafter made by said Commission.

STEP 1

Effective for a period of 24 months

APPLICABILITY

Applicable within the entire territory served.

AVAILABILITY

Available for general domestic, commercial, industrial and sale for resale water service.

(I) **RATES**

First 3,000 gallons used per month	\$8.70 per 1,000 gallons
Next 3,000 gallons used per month	\$8.38 per 1,000 gallons
Next 4,000 gallons used per month	\$8.26 per 1,000 gallons
Next 10,000 gallons used per month	\$7.83 per 1,000 gallons
Next 60,000 gallons used per month	\$6.67 per 1,000 gallons
All over 80,000 gallons used per month	\$5.79 per 1,000 gallons

(I) **MINIMUM CHARGE**

No bill will be rendered for less than the following based on the size of the meter installed:

5/8 -inch meter	\$ 26.10 per month
3/4 -inch meter	\$ 39.15 per month
1 -inch meter	\$ 65.25 per month
1-1/2 -inch meter	\$130.50 per month
2 -inch meter	\$208.80 per month
3 -inch meter	\$417.60 per month
4 -inch meter	\$652.50 per month

(I) **SALE FOR RESALE**

All water for resale will be billed at the rate of \$3.34 per 1,000 gallons

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the water utility up to a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by the bank due to insufficient funds.

STEP 1 (Continued)

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

RECONNECTION CHARGE

\$15.00

To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills, or fraudulent use of water.

TAP FEE

The following charge is to be made whenever the utility installs a new tap to serve an applicant:

A tap fee of \$350.00 will be charged to all customers who apply for service outside of the certificate proceeding before the Commission for each new tap to the system.

(D) **LEAK ADJUSTMENT**

\$0.96 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible leakage on the customer's side of the meter. This rate shall be applied to all such consumption above customer's historical average usage.

SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific class, or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provision.

APPLICABILITY

AVAILABILITY

Available for general domestic, commercial, industrial and sale for resale water service.

(D) **RATES**

First 3,000 gallons used per month	\$8.16 per 1,000 gallons
Next 3,000 gallons used per month	\$7.87 per 1,000 gallons
Next 4,000 gallons used per month	\$7.75 per 1,000 gallons
Next 10,000 gallons used per month	\$7.35 per 1,000 gallons
Next 60,000 gallons used per month	\$6.26 per 1,000 gallons
All over 80,000 gallons used per month	\$5.44 per 1,000 gallons

(D) **MINIMUM CHARGE**

No bill will be rendered for less than the following based on the size of the meter installed:

5/8 -inch meter	\$ 24.48 per month
3/4 -inch meter	\$ 36.72 per month
1 -inch meter	\$ 61.20 per month
1-1/2 -inch meter	\$122.40 per month
2 -inch meter	\$195.84 per month
3 -inch meter	\$391.68 per month
4 -inch meter	\$612.00 per month

(D) **SALE FOR RESALE**

All water for resale will be billed at the rate of \$3.14 per 1,000 gallons.

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the water utility up to a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by the bank due to insufficient funds.

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

RECONNECTION CHARGE

\$15.00

To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills, or fraudulent use of water.

TAP FEE

The following charge is to be made whenever the utility installs a new tap to serve an applicant:

A tap fee of \$350.00 will be charged to all customers who apply for service outside of the certificate proceeding before the Commission for each new tap to the system.

LEAK ADJUSTMENT

\$0.96 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible leakage on the customer's side of the meter. This rate shall be applied to all such consumption above customer's historical average usage.

SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific class, or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provision.
