

STEP I RATES

SCHEDULE I

APPLICABILITY

Applicable within the entire territory served

AVAILABILITY

Available for general domestic, commercial, industrial and sale for resale water service.

(I) **RATES** (Customers with a metered water supply)

First	3,000 gallons used per month	\$10.25 per 1,000 gallons
Next	7,000 gallons used per month	\$ 7.35 per 1,000 gallons
Next	10,000 gallons used per month	\$ 6.75 per 1,000 gallons
All Over	20,000 gallons used per month	\$ 6.12 per 1,000 gallons

(I) **MINIMUM CHARGE**

No bill will be rendered for less than the following amounts according to size of the meter installed.

5/8 inch meter	\$ 29.10 per month
3/4 inch meter	\$ 43.65 per month
1 - inch meter	\$ 72.75 per month
2 - inch meter	\$232.80 per month

(N) The above minimum charges are subject to an additional \$0.55 per thousand gallons used per month.

DELAYED PAYMENT PENALTY

The above schedule is net. On all accounts not paid in full when due, ten percent (10%) will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

RECONNECTION FEE \$20.00

To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills or fraudulent use of water.

TAP FEE

The following charge is to be made whenever the utility installs a new tap to serve an applicant:

A tap fee of \$100.00 will be charged to all customers who apply for service outside a certificate proceeding before the Commission for each new tap to the system.

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the water utility up to a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by his or her bank due to insufficient funds.

(I) **LEAK ADJUSTMENT**

\$7.40 per 1,000 gallons is to be used when a bill reflects unusual consumption which can be attributed to eligible leakage on customer's side of the meter. This rate shall be applied to all such consumption above the customer's historical average usage.

SECURITY DEPOSIT

Not to exceed two-twelfths (2/12) of the average annual usage of the applicant's specific customer class or fifty dollars (\$50.00), whichever is greater. This fee may be changed by applicable statutory provisions.

ADMINISTRATIVE FEE \$20.00

To be charged in the event the District collects payment in full of a delinquent water bill at the customer's premise in lieu of discontinuance of service for nonpayment of a water bill.




